Linking Boaters and Co-Anglers together assures that boaters are guaranteed to use their boat and Co-Anglers are guaranteed to be in the event. It is up to the Boaters and Co-Anglers to link together in order to create guaranteed status.

Important Note: Linking together does not mean the linked anglers fish together. Linking only guarantees the boater will use their boat in the tournament and linked co-anglers will be in the tournament and paired with a boater.
